Helen Pertsinidiis has circulated an appeal to club to fill the gaps in managing the Devonshire Tea stall and I'm happy to report that a number of us have been able to extend our support to fill in roles to ensure that this significant fundraiser goes ahead as planned.

Regarding our Open Garden fundraising involvement which has been so instrumental in providing substantial funding for our club projects, I have received a call from Kate Chattaway, our Open Gardens contact via the Silent Sewers. She is aware that Mary has expressed a concern regarding her continuation of this role and has approached me to step into Mary's shoes.

"Law is an area where you want Justice" - Claire O'Connor SC

In speaking to the Zonta Club of Adelaide, Barrister and Senior Counsel, Ms Claire O'Connor, explained that Australia's Legal Profession incorporated Senior Counsels, Queens Counsels and Kings Counsels and added that the profession was "Victorian in the way it punished people."

Ten years ago, when Ms O'Connor was appointed to the Bar, barristers could elect to become either a Senior Counsel (Ms O'Connor's title) or a Queens Counsel but the "minute Queen Elizabeth 11 died all Queens Counsels became Kings Counsels.

Women and the Justice System

Ms O'Connor who does family law, criminal law, refugee law, and civil law, then spoke about some of the difficulties of being a female lawyer, and about women facing the justice system.

She said that the legal profession had a high number of men in it and that the men were more highly paid than female lawyers.

"Wages in the profession reflect the wages of men, so if the number of men is low, the wages in the Legal Profession is low," Ms O'Connor said.

But women gained ground by achieving academically, and soon, 70 per cent of legal graduates were female.

"It is the first week ever when we also have more female High Court Judges than male," Ms O'Connor said.

Large wage difference at the Bar

"But the worst place to be is at the Bar, where I am – you go to court or you advocate," Ms O'Connor said.

Ms O"Connor added a large disparity existed between the wages of female Barristers (\$60,000), and a male Barristers' wage (about \$180,000).

She said that 25 per cent of Barristers being female was "unusual".

Ms O'Connor said that female Barristers experienced "bullying" with the Judge saying to them "where's your file? Go and get your file?"

About ten years ago the legal profession noticed many females were leaving the legal profession.

A National Attritution Study was done about this which revealed the women were not leaving to have babies but because of bullying, sexual harassment, and oppression!

In the law, in the first year, women make \$59,000 and a male would make \$64,000.

This not only dissuades women from achieving but it is bad because it is creating an environment which lacks diversity.

Ms O'Connor herself was brought up before the Legal Conduct Board for expressing an opinion about this problem.

Nepotism exists in the profession as well, and that legal appointments were done by the Attorney General's Department, the Judiciary and the Law Society.

With vacancies, if you apply you get a diverse bench but if a Judge says "go, and the appointment of a male is made, then there is no diversity," Ms O'Connor said.

"It doesn't matter if you are good at arguing your case, if a Judge does not support your case, it's bad." Ms O'Connor said.

Ms O'Connor said that almost all cases of domestic violence are women and most rape victims are also women but there have been more men on the High Court than women for a long time.

Justice and the Law

"Law is an area where you want Justice."

"If my colleagues can't get justice, what does that say about female lawyers," Ms O'Connor said.

"The number of women in the Legal Profession who experience sexual harassment is about 60 per cent," she said.

And, Ms O'Connor has become a member of the Law Society Council in a bid to change gender quotas.

The Law Society Council is a place where she can clearly see that women refugees, women who have experienced domestic violence and women who approach the justice system are generally still not getting justice.

"There has been a change in reporting sex crimes. Previously, you could punish women on their previous sexual history but these days it is very hard to do that," Ms O'Connor said.

"There was one instance where a seven year old victim had to sit on a pile of books to give evidence in court. Now children go on video.

Easy to get an acquittal on sex crimes

But sex crimes were still one of the easiest crimes for which to get an acquittal, Ms O'Connor said.

"Victims services, women's groups, balance it so that false allegations can be defeated," Ms O'Connor said.

Women's prisons

The situation in women's prisons is particularly bad and they are not funded as well as men's prisons.

Ms O'Connor said that out of 110 women prisoners, 95 per cent were victims of serious sexual violence before 15 years of age.

A group named Sisters Inside advocates for female prisoners.

Ms O'Connor said that "Australia was Victorian in the way it punished people."

When a crime is committed, what can the law do – punish the individual; reform the individual; set a sentence; deter the individual from participating in the community; deter the individual from committing another crime (by giving her or him a 5 year prison sentence).

"Many women in prison have children. What are they doing to the next generation by bringing children into the prison," Ms O'Connor said.

A large number of the perpetrators are teachers, uncles and other who know the victim.

"There is not a time limit on when one can sue and if the perpetrator has assets you can sue them. Superannuation can't be touched.

"Remember the man who sexually assaulted his daughter. In her forties she sued and got compensated.

"There are a number of teachers who sexually assaulted students and when the students wanted to sue the teachers they said 'she wanted to date me.' She was only thirteen," Ms O'Connor said.

Family Law

Ms O'Connor, who also deals with family law, said 50 per cent of people in the Family Law Court were women, and that the financial cuts to the Family Law Budget "were appalling" because the female partner generally has less money than their spouse or ex-spouse.

"I have mediated debts owed – lawyers do mediate for clients.

"Mediation can occur through the court system or independently, said Ms O'Connor, (who also has mediated industrial and commercial matters during her career).
